EVALUATION OF REQUEST FOR PROPOSAL (RFPS) OF PRE-QUALIFICATION BIDDERS FOR LEASING OUT OF PTDC PROPERTIES LOCATED IN GILGIT-BALTISTAN

Reference your Request for Proposal (RFP) submitted by you regarding the leasing out of PTDC properties in Gilgit-Baltistan in response to invitation letter dated 19-01-2023 which was issued to Nineteen (19) firms / pre-qualified bidders with the request to submit detailed proposals for the desired properties.

- 2. It is informed that in response to invitation letter, twelve (12) pre-qualified bidders submitted their Request for Proposals (RFPs) by the closing date i.e., 20.02.2023 which were opened by the Tender Opening Committee on same day in the presence of the representatives of bidders. Whereas seven (07) Firms/bidders did not submit their proposals.
- 5. The proposals were evaluated by the concerned tender committee in the light of evaluation criteria mentioned in Section-III of RFP. Out of twelve (12) bidders, technical proposals of bidders as per Table 'A' for the properties mentioned against their names were found as substantially responsive and qualified for open competitive financial bidding. Whereas technical proposals of bidders as per Table 'B' for the properties mentioned against their names were found non responsive for not meeting the qualification of minimum threshold. Detailed results are being shared for the information of the bidders to ensure transparency in process.
